# **Opening**

### **Group Discussion**

1. Update on lead film showing from Lorelei Walker, Health Equity Circle CHE-WA will host the viewing of a film on lead (MisLead) at the Seattle Home Show which will be February 20-28. They are thinking about also holding three interactive sessions and have been offered to hold them in the main auditorium. One session could be lead-safe work practices, one station with lead test kits, and one on regulations. Possible visuals include a Tyvek suit man. With funding, the producer Tamara Rubin could attend. In January they'll be looking for volunteers. The next Working Group meeting is in January.

Gretchen Stewart (EPA) said the Department of Commerce and EPA are hosting a booth for the 10 days of the Home Show and want partners. They are looking for \$700 in total funding. CHE could post their logo, have display space, and be able to help staff the booth.

Discussion followed about whether CHE-WA has any funds right now. Gail will talk to Steve Gilbert who keeps the funds. Another option is for CHE-WA member groups to provide funds. The group authorized the CHE-WA leadership group to make financial decisions regarding booths at the Home Show.

If there is opportunity for a speaker in the main auditorium, it was suggested to get a keynote-level speaker. Suggestions included Dr. Catherine Karr or Dr. Ada Otter from PEHSU, or have L&I speak on occupational lead standards.

## **Member Updates**

- Rachel Koller Cleaning for Health
  - Rachel, and Aimee Boulanger (Aimee is from Port Townsend), and Karen from Jefferson County Health District Environmental Health Consultant, would like to replicate Rachel's Seattle Public Schools "Cleaning for Health" presentation in Port Townsend. Rachel may be able to train parents from Port Townsend who can make the presentation. Nancy Bernard (WA DOH) offered to make the presentation, if needed as Nancy can go to any school in Washington State. Rachel's presentation is a 10-minute presentation at a staff meeting, directed to the whole school staff.
- Dennis Weaver Change Your Food Change Your Life ™ Dennis brought his new CD, "A Celebration in the Song of Livin' the Good Food Life" that promotes organic food. CHE-WA gets 10% of all proceeds. When users use the code, CHEWA10 and enter a C after their last name on checkout (for example "Weaver C") they get a 10% discount and CHE-WA gets \$2.00 per CD, or \$1.10 per CD download or \$0.38 per track. Dennis sold several CDs and handed in the portion for CHE-WA. Thanks, Dennis!
- Gail Gensler LHWMP
  - Gail expanded her child care outreach this fall and was able to train child care administrators and WA State Dept. of Early Learning licensors about how to reduce exposures to toxins in the child care setting. It was well received by the licensors. With the Best Start for Kids initiative passed, the King County Public Health nurses want to know what the new funding will mean. Gail will attend their meetings. Gail and Nicole Thompson will also attend a planning meeting for a different national initiative, First Thousand Days: Healthy Babies, Bright Futures, which is aimed at protecting babies from exposure to neurotoxic chemicals. They have named Seattle as one of its showcase cities. Gail reminded us that her job is morphing and someone else is needed to take over coordinating CHE-WA. This involves keeping track of information and sending invitations.
- Nancy Bernard <u>www.doh.school.environment</u>
   Nancy does school environmental health and safety for the WA State DOH, which includes offering cleaning guidance for schools, including alternatives to bleach for disinfection.
- Emily Polstein American Lung Association
   Emily is new to Seattle, having graduated from Oberlin College in June, and joining Americarps and ALA.
   She is doing home visits for air quality, for homeowners and renters in Seattle, and asthma visits to reduce and manage asthma triggers. The visits last about an hour.
- Katie Frevert UW Superfund Research Program (SRP) The UW SRP was re-funded through 2017 and is
  reapplying for the next grant cycle. The SRP has 4 investigators who do basic science research. They also
  have Community Engagement and Research Translation Cores that focus on disproportionately affected
  communities. SRP interacts with state agencies and organizations that have Superfund issues. UW-SRP
  developed a consortium of affected community groups so communities can talk to one another about
  common issues and concerns.
- Arthur Wendel ATSDR
  - ATSDR is working on a Child Care Siting Initiative, which is still in the formative stage. The initiative is writing a draft manual and guidelines to implement policies to review environmental hazards before a child care is sited. They are working to merge documents to provide guidance, collect guidelines at a national level, and write a schedule of policy changes. A website also is being developed to communicate the guidelines. The hope is to check for possible environmental exposures before a site is approved for a child care, and that, if something bad happens, to use the experience to improve for next time. They are using the PS Clean Air map of toxicants and WA State DOH mapping resources.

- Rhonda Kaetzel ATSDR. Rhonda wants to expand their work to issues in the other Region 10 states, Alaska, Idaho and Oregon.
- Lorelei Walker Health Equity Circle (HEC)
   Since the Best Starts for Kids initiative passed, HEC-WA will follow implementation to make King County accountable to distribute funds equitably. Lorelei is also looking for 25% FTE work in epigenetics and environmental health.
- Fran Solomon The Evergreen State College-Tacoma. Fran teaches environmental studies and focuses on pollution and toxic chemicals. She is teaching a 1-day course at Bastyr University on February 27<sup>th</sup> about endocrine disruptor chemicals. The course is targeted for environmental and health care professionals.
- Nancy Beaudet PEHSU. PEHSU is planning a Pediatric and Reproductive Environmental Health 'Boot Camp', 10 hours of instruction for clinicians and Public Health professionals for Region 10 states. Dr. Sheela Sathyanarayana (PEHSU) presented at the regional Obstetrics meeting in Silver Valley, Idaho about pediatric and reproductive environmental health, with a focus on lead. Dr. Ada Otter and Dr. Katherine Carr have joined the WA State Lead Screening Advisory Panel, advising on blood lead testing for children. L&I is holding stakeholder meetings for lead standards; Nancy is attending these meetings for PEHSU.
- Gretchen Stewart EPA. Working on smoke and children's health, also the Seattle Home Show. EPA
  partners with ATSDR and PEHSU on air quality, wood smoke, and nitrates.
- Megan Dunn NCAP. Filed comments with EPA about organic quality. NCAP is drafting a statement for the WA State PTA on issues around chemical use in schools, to promote indoor air quality and healthy schools. This information will allow PTAs to support legislation for safe chemicals and healthy schools.
